THE BRAINWARE UNIVERSITY (ANTI-RAGGING MEASURES) ORDINANCE, 2021

Ordinance No. 001 of 2021

Amendment to Section 15 of the Brainware University Statute, 2020

(In accordance with UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, and the West Bengal Prohibition of Ragging in Educational Institutions Act, 2000)

In exercise of the power conferred by Section 38, of the Brainware University act 2015 and in accordance with Section 49 of Chapter IX, First Statute, 2020, the following ordinance is hereby enacted:-

1. Short Title and Commencement

1.1 This Ordinance shall be called the **Brainware University Ordinance, 2021 – Section 15 (Anti-Ragging Committee)**.

1.2 It shall come into force on and from the date of its notification or as otherwise notified by the competent authority of the University.

2. Amendment to Section 15: Anti-Ragging Board

The heading and content of Section 15 titled “Anti-Ragging Board” in the Brainware University Statute, 2020, is hereby substituted with the following:

Section 15: Anti-Ragging Committee

(i) Anti-Ragging Committee

There shall be a Committee known as the Anti-Ragging Committee, which shall function in consonance with the provisions of:

(ii) Composition of the Anti-Ragging Committee

The Anti-Ragging Committee shall be constituted as follows:

Head of the institution – Chairperson

Representatives of civil and police administration

Representative of local media

Representative of Non-Government Organizations involved in youth activities,

Representatives of faculty members

Representatives of parents

Representatives of students belonging to the freshers' category as well as senior students,

Non-teaching staff

(iii) The Anti-Ragging Committee shall:

The Anti-Ragging Committee shall:

Ensure the implementation of anti-ragging measures across the University.

Monitor and review the progress of anti-ragging programs and initiatives.

Oversee the actions of the Anti-Ragging Squad.

Submit an annual report to the Governing Board with a copy to the competent authority.

(iv) Anti-Ragging Squad

The Anti-Ragging Squad shall remain constituted as per the original statute, continuing to make regular visits to the hostels and various parts of the campus, and shall submit reports after every visit to the Anti-Ragging Committee.

3. Continuity

This amendment shall replace the reference to the Anti-Ragging Board with the Anti-Ragging Committee, while retaining the existing provisions of the statute. All actions previously taken under the Anti-Ragging Board shall remain valid.

4. Repeal and Savings

1. All previous provisions, rules, regulations, or orders that are inconsistent with the provisions of this Ordinance shall stand repealed to the extent of its inconsistency.
2. Notwithstanding the amendment, all actions taken under the previous section-16 of Chapter II shall remain valid and in pace unless expressly altered.
